Dear Peter:

Still in the afterglow of the FDR Wheelchair Statue Dedication, I hesitate to return to such a mundane subject as budget. Nevertheless, as you and I have recognized for some months, this is the reality we must now address. As you suggested, I am forwarding our summary of expenses.

You were right in pointing out that the accelerated program for the FDR Wheelchair Statue Dedication could be accomplished for less than our original budget (\$85,000). You also were correct in raising the point that we would need additional support to meet the schedule. I am sure you are pleased, as Mike Deland and I with the results.
